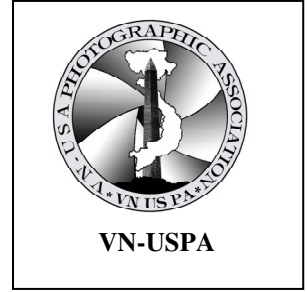
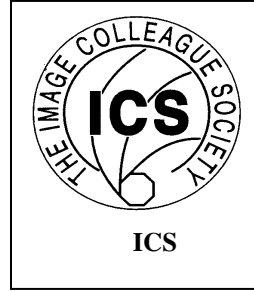


1st VNUSPA INTERNATIONAL DIGITAL SALON 2010

Acceptances: From this salon, exhibitors are eligible apply for **CPID** PSA star rating and FIAP distinction.

Conditions of Entry and Rules

1. The exhibition is open to anyone, except members of the Exhibition Committee and members of the jury. An entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to the exhibition rules and conditions.
2. The original image(s) must be made by the entrant on photographic emulsion or acquired with a digital camera. All images must be original and may not incorporate elements produced by anyone else. By virtue of submitting an entry, the entrant certifies the work as his/her own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in any medium related to the exhibition. The exhibition assumes no liability for any misuse of copyright.
3. This salon accepts new images only. An image previously entered in salons of USPA, FMPA, SWAN, SPA, VNUSPA, 35mmPCS, and ICS in the previous years is not eligible of entry.
4. The same image may not be submitted in more than one section. This means that the same image that is submitted in Travel Section can not be submitted in Color Section.

5. Entries receive without fee will not be judged; entries won't be returned.
6. A maximum of four images may be entered per section.
7. Report cards will be sent to email only.
8. Decisions of the jury are final.
9. All images will be projected for judging in public. The winning images will be projected for public show at the community gallery. The entries – online and/or postal - will not be returned.
10. Please be aware that we will only contact you via email; therefore, provide your working email address.

Digital Images

1. All entries must be in JPEG.
2. Maximum image width (horizontal) is 1024 pixels, and maximum image height (vertical) is 768 pixels.
3. Please use dpi 72
4. An image must not exceed 850 KBs.
5. The maker's name and/or image title must not be in the image.

Definitions

1. **FIAP** definition of Monochrome Photography: A black and white work fitting from the very dark grey (black) to the very clear grey (white) is a monochrome work with the various shades of grey. A black and white work toned entirely in a single colour will remain a monochrome work able to stand in the black and white category. On the other hand a black and white work modified by a partial toning or by the addition of one colour becomes a colour work (polychrome) to stand in the colour category.
2. **PSA** definition of Photo Travel: A Photo Travel slide, print or digital image must express the feeling of a time and place, portray a land, its people, or a culture in its natural state, and has no geographical limitations. Ultra close-ups which lose their identity, studio-type model shots, or photographic manipulations that misrepresent the true situation or alter the content of the image are unacceptable in Photo Travel competition. No pictorial elements may be moved, cloned, added, deleted, rearranged or combined. No manipulation or modification is permitted except resizing, cropping, selective lightening or darkening, sharpening, and restoration of original color to the scene. Any adjustments must appear natural.

How to Enter

1. Online Entry: online digital entries must be submitted via <http://www.vnuspa.org/salon/onlineentry.php>
2. Postal Entry: Non-online digital files must be stored in a DVD/CD containing the works. Files naming must follow the format: lastname-firstname-section-entry#-ImageTitle; for example: Lee-Jasmine-Color-2-CatchAFish.jpg. In addition, the Image titles on CD/DVD have to match with image titles on entry form.

Note: Entries not complying with Conditions of Entry and Rules will be disqualified.
Entries received without full payment of entry fee will be disqualified.

Entry Fee:

1. Online submission: PAYPAL ONLY, \$12 / entry
2. Postal submission: CASH ONLY, North America US\$13.00, others US\$15.00.
3. GROUP ENTRY: There is a US\$30.00 group discount for entries consisting of 10 separate entrants or more.

Awards

1. VNUSPA intends to award more than 50 awards at the discretion of the judges. These include PSA FIAP and ICS medals.
2. Each section will include 1 gold, 2 silver, and 3 bronze awards, in addition to other honorable mentions.

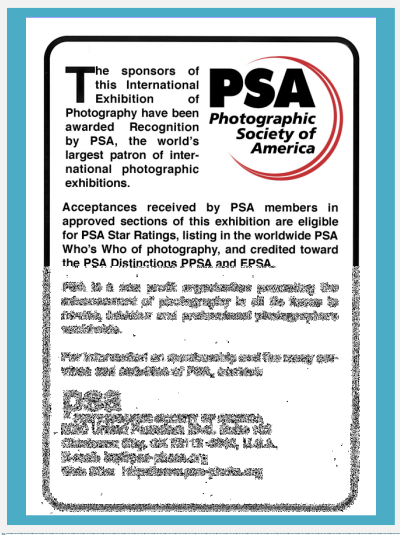

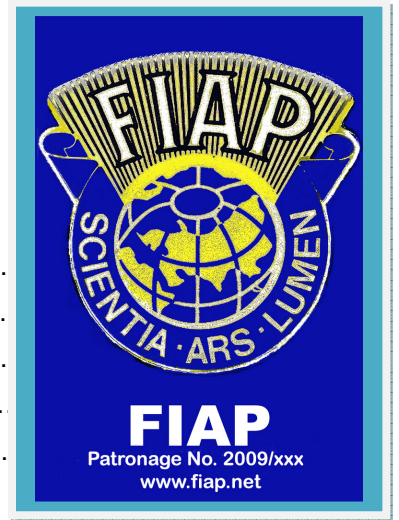
